This month's topic of interest: January 2015

Each month our staff takes a number of calls from people within the North Central Florida Community. Although we aren't always able to take every case we receive, there is always an opportunity to educate others. Here's a topic worth discussing.



Four Florida Cities Rank Among **Top 10 Most Dangerous Cities for** Pedestrians.

Every two hours, a pedestrian in America dies in a traffic accident. Accounting for 21 percent of these deaths are seniors aged 65 and older. In 2013, crashes killed 36 pedestrians and injured another 534 in the city of Orlando and Orange County.

Walking can be risky in many cities and towns across the country. Between 2003 and 2012, crashes killed 47, 025 pedestrians nationwide and injured another 676,000, according to the "2014 Dangerous by Design" report on pedestrian safety by Smart Growth America. Reducing those numbers has proved to be difficult: Distracted drivers increasingly look at phones instead of the road; people cross streets where they shouldn't; cities and suburban areas have been built to move 2. Tampa, FL traffic, not to keep pedestrians safe.

Older people bear a higher risk as they navigate city streets on foot. Those 65 years and older make up about 13 percent 5. Memphis, TN of the population, but account for 21 percent of pedestrian deaths.

To better educate pedestrians, The Best Foot Forward coalition gives presentations several times a month at local churches, Rotary Clubs, and senior living centers explaining where and when pedestrians can cross streets, and how they can stay safe on the streets. A major concern is that the traffic signals are too short, which can be a particular problem for older people on wide, multi-lane streets. More than half of pedestrian traffic deaths over the past decade occurred on these types of high capacity roads through suburban sprawl, where drivers often

More than 90 percent of the people hit by cars traveling at 20 miles per hour survive the crash, but at 45 miles per hour only 35 percent live. Better design of roads could help the problem. If a boulevard has a raised median, pedestrians can pause and wait for traffic to clear, and overhead lights make crossing less treacherous after

Recipe of the Month: Bacon Wrapped Stuffed Dates with Blue Cheese.

This New Year's nibbler will be a party favorite amongst your guests!



Ingredients:

- 1 pound sliced bacon cut in half. 3
- 1 pound pitted dates.
- •4 ounces of blue cheese.

Directions:

- Preheat oven 375 degrees F (190 degrees C).
- Slice dates in half, and open them up. Pinch off pieces of blue cheese, and place them into the center of the dates. Close the halves of the dates, and wrap a half-slice of bacon around the outside. Secure each one with a toothpick. Arrange in a baking dish or on a baking sheet with sides to catch any grease.
- Bake for 30 to 40 minutes in the preheated oven, or until the bacon is crisp. Turn dates over after the first 20 minutes for even cooking.
