Bicyclists-Know the Law and Stay Alive

Bicycles are vehicles under Florida law. Therefore, riders are accountable for traffic laws just like drivers of cars and trucks. <u>This means that bicyclists must:</u>

- Come to a complete stop at stop signs;
- Obey traffic lights;
- Ride with the flow of traffic; and
- Comply with DUI laws—no drinking and riding.

In addition:

- Riders under 16 years of age must wear a helmet.
- Cyclists may not wear headphones or other listening devices.
- Cyclists must keep one hand on the handle bars at all times.
- Bikes must be equipped with a bell, seat, brakes, and lights.
- Cyclists must yield to pedestrians, use proper hand signals, and may not ride "two abreast."



It's time to "BE TIRE SMART"

It is that time of year—time to "be tire smart" before you hit the road. Improperly maintained tires can cause an accident any time of the year and in any weather. Tires are especially vulnerable to summertime heat, vacation travel, and overloaded vehicles. The Rubber Manufacturer's Association (RMA) urges all motorists to "Be Tire Smart—Play Your PART." PART is RMA's acronym for: Pressure, Alignment, Rotation, and Tread. Here are four essential tire care tips:

Pressure: Check your tires' pressure monthly and before the start of a long driving trip by using a tire gauge on a cool tire. Under inflation is the leading cause of tire wear and failure.

Alignment: Wheel misalignment can cause uneven tread wear. Potholes and rough roads contribute to alignment problems.



Rotation: Each tire on your vehicle supports different amounts of weight. Rotating tires will achieve more uniform tire wear and extend their life. A general rotation guideline is every 5,000 miles.

Tread: Tread is your vehicle's connection to the road. Inadequate tread reduces the ability of your tire to grip the road, especially in adverse conditions and when taking corners. Check each of your tire's tread by inserting a penny head down into the tread. If you can see the top of Abe's head, it is time for a new tire.

Note: Not only do these tire care tips save money at the pump and prolong the life of your tires, they also save lives.

Can I get pulled over just for not wearing my seatbelt?

Answer: Yes! Florida made not buckling up a "primary offense" three years ago in June 2009. This means that a police officer can pull you over based solely on not wearing your seatbelt. Florida law requires front seat occupants of a vehicle (driver and passenger) to buckle up. All passengers and drivers under 18 years of age are required to wear a seatbelt or be in a child restraint system at all times. More reasons to buckle up every time:



- Motor vehicle crashes are the leading cause of death among people under 45 years old and the number one cause of head and spinal cord injury.
- Seatbelts, when used properly, reduce the number of serious traffic injuries by 50 percent and fatalities by 60-70 percent.
- A common cause of death and injury to children in motor vehicles is being crushed by adults who are not wearing safety belts.
- Of every 100 children who die in motor vehicle crash, at least 80 would have survived if they had been properly secured in an appropriate child safety seat or safety belt.
- An unrestrained child in a 30 mph crash is the equivalent of falling from a 3 story building.
- Young men between the ages of 18 to 34 are most at risk for being killed in a crash due to not buckling their seatbelt.
- In a 30 mph collision, an unbelted 160 lb person can strike another passenger with 4,800 lbs of force.
- Seatbelt use is one of the best defenses against a distracted or drunk driver.
