November—Time to Give Thanks!

Veterans Day and Thanksgiving—both days to stop and give thanks.

The first Veteran's Day, then called Armistice Day, was November 11, 1919. President Wilson described it as, "a day to be filled with pride in the heroism of those who died in the country's service and with gratitude for the victory." In 1926, President Coolidge made November 11 a legal holiday, "a day to be dedicated to the cause of world peace." In 1954, President Eisenhower signed a bill that changed the name to Veterans Day, a day to celebrate all veterans, not just those who died in WWI. Veterans Day, unlike Memorial Day, is a day to be thankful for all of our soldiers, living and fallen, who have served our country.

There is much romanticism surrounding the history of Thanksgiving. However, one point that historians can agree on is that it began as a celebration of thankfulness. The first Thanksgiving was in St. Augustine, Fl. on September 8, 1565, celebrating the safe landing of 800 Spanish settlers. The celebration consisted of a mass followed by a meal shared with the Native Americans. Fifty six years later, the Puritan Pilgrim settlers in Plymouth Colony had a three day corn harvest celebration sometime between late September to mid November. There are many myths about the 1621 harvest festival, but some things historians know to be true:

- Cranberry sauce and potatoes (white or sweet) were not on the menu, nor were pies!
- Approximately 90 Wampanoag Indians and 52 colonists attended.
- The Native Americans contributed at least five deer to the feast.

Daylight Saving Time, which began last spring on March 11 at 2:00 A.M., will come to an end on November 4 at 2:00 A.M.

As the saying goes, "Spring forward, Fall back." In other words, when we turn our clocks back, we will get an "extra hour" of sleep. However, the changing of clocks also creates a hazard on the road.

Pedestrians are <u>three times more likely</u> to be hit and killed by cars in the early evening hours during the weeks following the shift back to Standard Time than in the month before—6 P.M.

News Alert—You may have a dangerous airbag in your vehicle and not know it!

Recently, the National Highway Traffic Safety Administration (NHTSA) issued a news alert for vehicle owners who may be at risk for having counterfeit and dangerous airbags in their vehicle without their knowledge. Who is at risk?

- Vehicle owners who have had their airbags replaced within the last three years at a repair shop that was not part of a new car dealership.
- Consumers who do not know the full history of their used car.
- Consumers who purchased replacement airbags at a low cost from an on-line source or repair shop (i.e. less than \$400).

Are you an unsafe or aggressive driver? Take the test and find out!

Thanksgiving weekend is around the corner, which means that many of us will take a road trip to celebrate the holiday with family and friends or just enjoy a long weekend vacation. In addition to checking that your tires and engine are ready for the road, make sure that your vehicle is not over packed and avoid driving while distracted or drowsy. Drive safely.

Aggressive driving is responsible for two-thirds of auto-related fatalities, four times greater than DUI related deaths. So, take the test and see if you are an unsafe or aggressive driver. **Do you:**

- Exceed the speed limit by 15 mph or more?
- Unsafely or improperly change lanes?
- Follow the vehicle in front of you too closely?
- Fail to yield the right of way?
- Improperly pass other vehicles?
- Violate traffic control and signal devices?

If you answered "Yes" to any of these questions, you are an "Unsafe" driver.

If you answered "Yes" to two or more of these questions and display them simultaneously, you are an "Aggressive" driver by Florida law.

According to the National Highway Traffic Safety Administration, an aggressive driver will: run red lights and stop signs, speed, tailgate, weave in and out of traffic, pass on the right, scream and honk, flash lights, and make threatening facial and hand gestures.

What can you do if you see an aggressive driver? Stay calm, give him space, and call the Florida Highway Patrol on your cell phone. The number is *FHP (*347) and you can call anonymously. This is also the number to call for roadside assistance.
