## Safety Reminder: Bicycling over the legal limit is unsafe and illegal!

Florida leads the country in bicycle rider fatalities. Statistics show that one-quarter of those riders killed were over the limit.

You can also be arrested for DUI for riding drunk. Here is why:

1. DUI stands for driving under the influence. It is defined as the act of driving or being in actual physical control of a

vehicle when your normal faculties are impaired by alcohol or drugs

(legal or illegal), or when you have a BAC of .08% or higher.

# Two pedals, two feet? The controversy continues...



Which foot to use to apply pressure to the brake pedal in an automatic transmission vehicle is a controversial topic among family members and the community at large.

The proponents of left foot breaking believe it decreases braking time by eliminating the time it takes to move the right foot from the gas pedal to the brake. However, for this decreased braking time to occur requires having the left foot hovering over the brake pedal at all times and not planted on the floor board helping to brace the driver when it becomes necessary to apply the brakes in an emergency situation.

The problem with "hovering" is most left-foot-brakers tend to let their foot rest on the brake pedal itself. If that is the case, as their foot settles onto the brake a little, it will activate the brake lights, and the driver behind won't know if they are braking or not. Also, if a driver lets their foot rest on the brake pedal, even if they do not feel it, they are probably wearing out their brakes, reducing their fuel economy, and probably reducing the effectiveness of their brakes when they actually stop. Opponents of left foot braking have also noted that in a panic situation, it is possible that the driver could push both pedals applying brakes and gas at the same time ending up accelerating into an accident.

**Staunch opponents** of left foot braking state, "Unless you're planning on competing in the Formula One, the safest place for your left foot while driving an automatic is firmly on the floor." (Note: Both methods are legal)

# Case of the month—Make sure to hire a lawyer that is willing to go to trial

Several years ago a University of Florida student was riding his motor scooter on University Ave. and was rear-ended by an inattentive driver. The young man came to us for legal help. Our client had suffered a wrist injury and hit his head on the pavement. He did not have a major head injury but did need to get special arrangements made by the university because he was having trouble remembering and processing information.

We hired a forensic psychiatrist to evaluate our client, and he determined that our client had early signs of progressive dementia due to the head injury. The insurance company made an offer that barely covered our client's medical bills.

We then filed a lawsuit because the insurance company refused to increase their offer. After a year of litigation the insurance company made a slightly higher, yet inadequate offer at court-ordered mediation.

Finally, the insurance company realized that it was facing serious risks if this case was taken to trial and, therefore significantly increased its offer. We settled our client's case just before trial.

The moral of the story? It is important to hire a law firm that is willing to file a lawsuit and go to trial for their clients when it is in the client's best interest.



# **Should You Have Gap Insurance?**

What is Gap Insurance? Gap insurance, sometimes called "totaled insurance," provides valuable protection if your "totaled" or stolen car is worth less than the amount of your bank loan or lease pay-off. This is called being "upside down" or "underwater" on a loan.



Who needs Gap Insurance? Anyone who purchases or leases a new or nearly new car with a loan for close to the full purchase price or less than 20% to 50% down payment and drove it off the car lot is at risk and should consider purchasing Gap insurance.

Why would you need Gap Insurance? Because Florida law only requires insurance companies to pay fair market value for "totaled" or stolen vehicles. This means, no matter who is at-fault for the accident or if both you and the other driver have collision and property damage liability insurance, you can still end up paying out-of-pocket on a loan for a car in the junk yard.

Here is an example: Let's say you purchase or lease a newer model car or truck for \$25,000. Several months later, or the moment you drive it off the car lot, it is "totaled" or stolen. Your insurance company will only pay you what it decides the vehicle is currently worth (fair market value) and not necessarily what you owe on the car. In this case, the reimbursement could be \$20,000, leaving you to pay the remaining \$5,000 out-of-pocket to the finance company or the lease company if you had not purchased Gap insurance beforehand.
