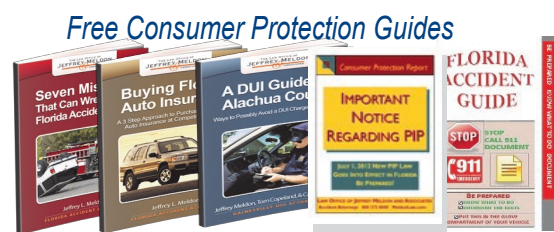

## This month's topic of interest: January 2015

Each month our staff takes a number of calls from people within the North Central Florida Community. Although we aren't always able to take every case we receive, there is always an opportunity to educate others. Here's a topic worth discussing.

### Emergency Medical Services Prep

It's important to stay safe, and to make sure you can be reached in times of emergency. Here are six tips on how to be better prepared in a worst-case scenario.

**1. Be accessible to EMT's:** Make sure Emergency Medical Services (EMS) has unimpeded access to your driveway. If you live in a single family home, keep trees and bushes trimmed, and if you live in an apartment alert your management that a Emergency Medical Technician (EMT) will need access to your building. They can break down your door if need be, but a faster solution is a spare key. Hide the spare key in a place you will remember to tell dispatch, or call the local EMS and ask it to note the location in their database. If you are in an apartment, make sure management will have the spare key available for EMT's. If EMT's cannot get past your locks, they may not be able to get to you in time. If you are at work, make sure you alert security after calling 911, so they know where to direct the EMT's.

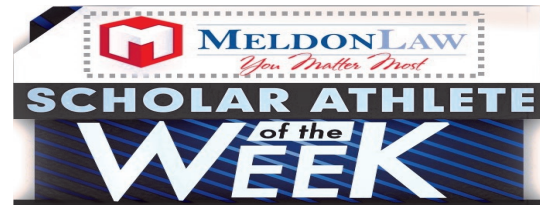
**2. Make your house a beacon:** To help EMS find you, make sure your house or apartment number is clearly visible, especially at night. If you live in a house, use reflective numbers, or mark the curb with reflective paint. If you live in a condo or apartment, ask management for abundant lighting.

**3. Declutter your home:** A cluttered house can keep EMS from getting a stretcher into the room where it is needed, and delay life-saving CPR. Make sure to keep pathways between rooms clear. If someone in your household is bedbound, keep space open around them to allow EMTs access.

**4. Keep records handy:** If EMT's find you alone and unconscious, they will have no idea where to find your medications and records. Keep health cheat sheets on your fridge with a list of your current physicians, medications, and surgeries. Make sure a copy of any advance directives is close to hand.

**5. Swap out Confusing Jewelry:** There is a recent trend of "fashionable" medical alert bracelets that are unfortunately confused for standard jewelry. The red Star of Life symbol incorporating a medical staff is instantly recognizable and sends the message loud and clear.

**6. Alert EMS to Special Circumstances:** Occasionally there are situations that an ambulance crew of two EMT's is incapable of handling without backup or special equipment. Phone your local EMS and add a note to your home address file of any special circumstances EMT's should be aware of; for example; a person of size or a dog that may be aggressive to strangers.

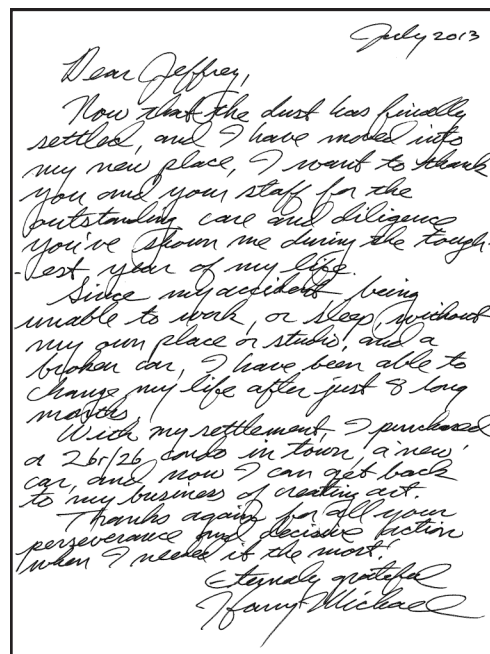
