

## Danger Everywhere for Pedestrians

A recent study by Smart Growth America concluded that the 7 most dangerous places in the United States for pedestrians all surround Gainesville and Ocala, FL. Wow! That sounds unbelievable but it's true. Orlando, Daytona Beach, Jacksonville, Lakeland, Tampa, Melbourne and Fort Myers are all on the top of the list. And Sarasota and South Florida are not far behind. The good news is that Gainesville and Ocala are among the safest walking cities in the country. I am not sure why our neighbors are so darn dangerous, but it has something to do with roads being built so cars can go faster. In fact, the Florida Department of Transportation adopted a Complete Streets policy which has as its goal to reduce pedestrian deaths in Florida. Every day there are 13 pedestrian deaths in the United States, and Florida has much more than its fair share. To protect yourself when visiting our neighboring cities remember the basics:

1. Walk facing traffic.
2. Wear clothing that is easily visible.
3. Avoid distractions.

Distractions is a big one. I see everyone on their cell phones walking around oblivious to what is going on. It has become an epidemic. Also be careful when walking or jogging with headphones. You can't hear the ambient noise that alerts you to danger. So I guess walking now requires us to be just as watchful as when we are driving. We have represented a number of people and their families who have been injured or killed in pedestrian vs. motor vehicle accidents. The injuries are usually more serious because as a pedestrian you are not protected and receive the full force of being hit by the car or truck, and when you slam down on the pavement the outcome is usually bad. So just think about how you can be a safer pedestrian and don't count on the person in the car or truck to be looking out for you. And by all means take even greater care when you visit the more dangerous cities all around us.

## Recipe of the Month....Strawberry Confetti Pancakes

### Ingredients:

- 1 cup all purpose flour
- 2 tbsp. granulated sugar
- 1 ½ tsp baking powder
- ¼ tsp kosher salt
- 1 cup of whole milk
- 1 egg
- ½ tsp vanilla extract
- 2 tbsp. butter, melted
- 5-6 medium-sized strawberries, sliced
- sprinkles of your choice



### Instructions:

1. In a small bowl, mix together milk, egg, and vanilla extract. In a separate bowl, mix together flour, sugar, baking powder, and salt.
2. Make a well in the flour mixture and pour in the milk mixture, mixing well and then adding in the melted butter and stirring until combined.
3. Heat a sauté pan over medium-low heat and butter or spray it with cooking spray. Once hot, scoop ½ cup of batter into the pan. Immediately lay 3-4 strawberry slices on each pancake, gently pressing each one in. Sprinkle with sprinkles and let it cook for about 2 mins or until golden brown, flip to the other side and cook for another 1-2 mins.
4. To serve, place strawberry side up and sprinkle with confectioners sugar, or whipping cream and more sprinkles if desired.

## This month's topic of interest: February 2017

Each month our staff takes a number of calls from people within the North Central Florida Community. We use our clients' comments to come up with ideas for the topics of interest.

Here's a topic worth discussing.

### Golf Cart and ATV Laws in Gainesville and Ocala

Floridians are blessed with almost year-round warm weather and, many Floridians love to take advantage of golf carts, all-terrain vehicles (ATVs), and other motorized vehicles. These vehicles are popular due to their simplicity and the ability of the driver to experience the warm, sunny day. However, because of their simple nature, many of these vehicles can be very dangerous and every year numerous Floridians are injured or killed using them. As such, the law limits where they can be used and who can use them.

#### Golf Cart Laws

Although some counties in Florida have more specific regulations regarding golf carts, Florida state law on the matter is sparse. As far as safety, Florida's laws are limited to ensuring that the golf cart works, keeping golf carts off of roads not designated for use by golf carts, and limiting use of golf carts to only individuals over the age of 14. Importantly absent is the requirement of seatbelts. Although not having a seatbelt while riding around a golf course doesn't seem too dangerous, not having one when operating a golf cart near or on a road could prove considerably more dangerous. Alachua County has no regulations regarding the use of golf carts, meaning only the state laws apply and golf carts may not be used on public roadways. In Marion County, individuals within the unincorporated area known as The Villages are allowed to use golf carts on the roadways.

#### ATV Laws

ATVs are defined by Florida Statute §317.0003(1) as any motorized off-highway or all-terrain vehicle 50 inches or less in width, weighing less than 1,200 pounds, designed to travel on three or more tires, with a seat designed to be straddled, and handlebars for steering. The laws regarding ATVs are fairly similar to those of golf carts. First and foremost, Florida Statute §316.2123 directs that ATVs cannot be operated on a public road with the sole exception of being allowed to drive on unpaved public roads with speed limits less than 35 miles per hour and this can only be done during the daytime. Next, Florida Statute §251.20(3) states that any ATV rider under 16 must be supervised by a licensed driver and must wear a helmet, over-the-ankle boots, and eye protection. Further, any rider under 16 that wishes to ride on public land must pass a safety course. In addition, ATVs cannot have more than one person on them unless they are specifically designed to be two-rider ATVs. It is important to note that Alachua County has passed an ordinance that prohibits the use of ATVs on any public roadways, regardless of whether it is paved or not. In Marion County, the law is the same as the state law. According to Florida Statute §261.20(6), violating any of these laws related to ATVs is a noncriminal offense that will result in a fine of not less than \$100. If you violate any of these laws, you may also be prohibited from operating an ATV on public land. Golf carts, ATVs, and other motorized vehicles can be great fun on a nice day. It is important to remember the laws controlling their use and even more important to remember to be safe since these vehicles do not have the same safety features designed to protect you as cars. Two of the best ways to protect yourself in golf carts and ATVs is to avoid high speeds and sharp turns since both will increase the risk of rolling over.
