

# Tom Petty: The Biography by Warren Zanes

Prior to Tom Petty's untimely death on October 2, 2017, a complete authorized biography was written by Warren Zanes with Tom's permission and input. Not only was Petty interviewed extensively for this journey though history, but all of the significant people in his life were as well. The

Heartbreakers discuss poignant moments as the band emerges from small town Gainesville, Florida to become one the biggest names in music and the eventual enshrining of Tom Petty and the Heartbreakers as members of the Rock n' Roll Hall of Fame. The biography also describes stories like Tom Petty being awestruck when his uncle Earl Jernigan arranges for a young Tom to meet Elvis Presley during a film shoot in Ocala, Florida, or how Tom's life was forever changed when he first saw the Beatles on the Ed Sullivan show.

The rise of Tom
Petty started in the 1960s while
the members of the
Heartbreakers were in other
bands honing their craft for an
uncertain future. The Tom Petty
band I first met in 1970 was
called Mudcrutch which included
Tom Leadon (brother of Bernie
Leadon of the Eagles), Randall

Marsh, and Mike Campbell. Mike went on to become Tom Petty's all-star lead guitar player and co-writer for many of the bands greatest hits. I worked with Tom and the band to create the first Mudcrutch Festival in Gainesville in December of 1970. It turned out to be a mini Woodstock that was expanded to a 3 day event in the early part of 1971. After I opened my law office in November of 1971, I represented Tom and the band as their first lawyer, helping them develop their career. Eventually the band broke up and reformed with Tom, Mike Campbell, Ron Blair, Stan Lynch, and Benmont Tench as Gainesville's own Tom Petty and the Heartbreakers. It took many years before they made it to the big stage but they remain today as Gainesville's, and probably Florida's, greatest rock n' roll band.

I remember just like it was yesterday when the group came to my law office to plan their future. Reading this book brought back so many great memories since I personally knew many of the people involved and stories told.
