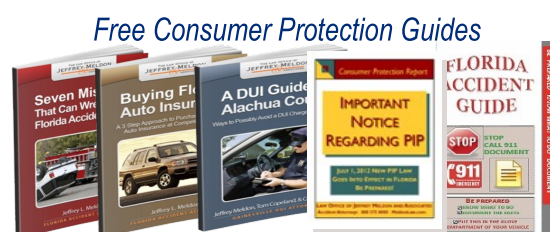

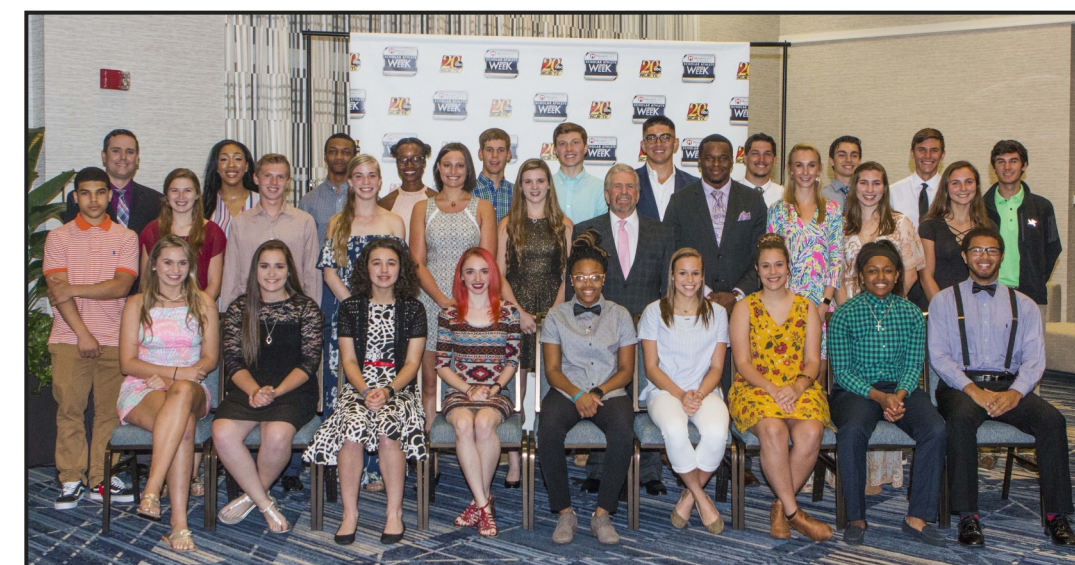

Each month our staff takes a number of calls from people within the North Central Florida Community. We use our clients' comments to come up with ideas for the topics of interest. Here's a topic worth discussing.

Jeffrey Meldon Abroad In Israel

Jeffrey went on a trip with the Greater Miami Jewish Federation from April 15, 2018 until April 23, 2018 to celebrate the 70th Anniversary of the founding of modern day Israel. Among the highlights of his trip, Jeffrey visited the Israeli Emergency Ambulance and Blood Bank headquarters Magen David Adom in Jerusalem. Jeffrey's daughter Jessica is the Director of Major Gifts for the American Friends of Magen David Adom (The Red Star of David) in Miami. The Lombardi family from Miami was donating a Medicycle (pictured below) that will help save lives especially in heavily trafficked big cities where congestion is significant and time is of the essence. On the day that Jeffrey visited the Jerusalem headquarters, the average response time from the initial emergency call until a qualified medic was at the scene was 3 minutes and 35 seconds. This is accomplished because there are 10 volunteers for every full-time personnel and everyone is prepared to rush to the scene when they are alerted by text wherever they are. The dispatch center determines the nature of the emergency and codes it and then follows it throughout on the computer screens.

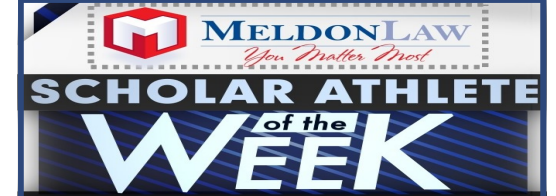
Jeffrey also visited the Western Wall of the Second Jewish Temple destroyed by the Romans in 70CE with his good friend Henry Flescher. Henry, age 94, is a holocaust survivor and has visited Israel many times since his first visit in 1968. This is the holiest site in Judaism.
