Danger on Florida Roads

Many folks in Florida are unaware that most drivers on the road can seriously injure you and walk away 'scot-free'. Anyone riding a motorcycle is at high risk for injury and should make sure you have good uninsured mo-



torist coverage not only on your car, but on your motorcycle as well. Put it on one policy and make sure you get stacking coverage.



Stefany's White Chicken Chili

Ingredients:

- 1 Packet McCormick's White Chicken Chili Seasoning
- 6-8 boneless chicken thighs
- Chicken broth
- Red bell pepper (chopped)

- 6. Add chicken and bring to a boil and then reduce heat and simmer for about 45 minutes.
- 7. Top with shredded cheese, sour cream.

Auto Accident Data For Florida

Each year, the State of Florida releases statistics regarding auto accidents throughout the Sunshine State for the previous year. As 2018 comes into full swing, it can help to look back at the prevalence of auto accidents and injuries and to find ways to increase safety on the roads. The following are some statistics regarding traffic crashes in Florida in 2017:

- Total crashes reported = 389,641
- Crashes that caused property damage only = 225,043
- Crashes that caused injuries = 161,886 (with a total of 247,198 people
- Crashes resulting in fatalities = 2,732 (with a total of 2,915 fatalities)
- Crashes involving commercial vehicles = 42,194
- Crashes involving pedestrians = 9,057 (with 607 fatalities)
- Crashes involving bicyclists = 6.462 (with 107 fatalities)

Even though the numbers have decreased a small amount from 2016, hundreds of thousands of people still suffer injuries each year in traffic acci-
