## \$185,000.00 SETTLEMENT: LATE NIGHT ROAD CREW NEGLIGENCE

Our client was a passenger in a pickup truck proceeding northbound on a state highway late at night. As the pickup truck was approaching a road crew painting stripes on the median of the highway, one of the road crew workers began lowering a huge cannister containing paint and sand from the back of a construction truck. At the precise moment that the pickup truck was passing the construction truck, the road crew worker pushed the paint cannister directly into the northbound lane of the highway,

causing the cannister to strike and severely damage the pickup truck (including knocking off its passenger side mirror). Our client suffered injuries to his left shoulder, neck and back. Initially, the insurance company for the road maintenance company denied liability and offered nothing for our client's injuries. However, a thorough investigation of the incident by Meldon Law, and the testimony of an independent witness convinced the insurance company to change its mind and settle the claim for \$185,000.00.



## RECIPE OF THE MONTH - KERRY'S DEVILED EGGS!

### INGREDIENTS:

- 6 eggs
- 1/4 cup mayonnaise
- 1 teaspoon white vinegar
- 1 teaspoon honey mustard
- 1/8 teaspoon salt
- Freshly ground black pepper
- Paprika, for garnish



### DIRECTIONS:

- 1.) Boil 6 eggs for 13 minutes on medium to high heat. Drop your eggs and start your timer when the water begins to boil.
- 2.) Once the eggs have boiled dump out the hot boiling water and fill the pot up with cold water (this will stop the eggs from cooking).
- 3.) Peel shells off eggs
- 4.) Cut eggs in half vertically and scoop out the yellow yolk and throw into a bowl.
- 5.) Using a fork, break up the yolk as much as possible before adding mayonnaise, white vinegar, honey mustard, salt and pepper. Mix ingredient together (for a smoother texture you could also blend the yolk and condiments together with a hand mixer).
- 6.) Scoop egg yolk mixture into the egg whites and garnish with paprika or any garnish of your liking!
