## RECIPE OF THE MONTH - MARIA'S SUMMER STRAWBERRY SALAD

### INGREDIENTS:

- 8 cups kale
- 5 tablespoons extra virgin olive oil
- ½ teaspoon of salt
- 1 tablespoon apple cider vinegar
- 1 teaspoon dijon mustard
- ¼ teaspoon ground pepper
- 1 ½ cups halved strawberries



### DIRECTIONS:

Combine kale, 2 tablespoons of oil and 1/4 teaspoon salt in a large bowl. Using your hands, massage the kale until well coated, about 1 minute. Whisk vinegar, mustard, pepper and the remaining 1/4 teaspoon salt in a small bowl. Whisking constantly, slowly drizzle in the remaining 3 tablespoons of oil. Add strawberries, goat cheese and walnuts to the kale; drizzle the dressing over the salad and gently toss to combine.
