## RECIPE OF THE MONTH - ANGELA'S COLOMBIAN AREPAS

### INGREDIENTS:

- 2 cups of Masarepa - GOYA® Precooked Yellow Corn Flour
- 2½ cups warm water
- A pinch of salt
- 1 tablespoon vegetable oil
- 2 cups of prepared shredded meat
- 1 sliced avocado



### DIRECTIONS:

- 1) Spread the oil in a large skillet and place it on the stove over medium-high heat.
- 2) Place water and a pinch of salt in a bowl; little by little add the flour and stir with a spoon. Wait about three minutes until the dough takes a little consistency.
- 3) Cook the arepas in batches, turning them halfway through the cooking time, 6 to 7 minutes, or until golden brown. If necessary, you can clean the pan and add more oil. Transfer the arepas to the preheated oven to keep them warm.
- 4) To serve, cut the arepas in half, horizontally, without cutting them completely. Divide the meat filling between the arepas, add the avocado slices and serve.
