## RECIPE OF THE MONTH - JAMIE'S SPAGHETTI ALLA CARBONARA

### INGREDIENTS:

- 1 box of spaghetti (not angel hair pasta)
- Salt: as needed
- Black pepper: as needed
- Freshly grated Parmesan (or Pecorino Romano) cheese: about 2 oz
- Eggs: 1 whole egg and 3 egg yolks
- Pancetta or bacon: 5 oz (cubed)
- Whipping cream: 8-10 oz

### DIRECTIONS:

1. Bring to a boil a pan of salted water for the spaghetti. In the meantime, cube your pancetta or slice the bacon in small, bite-sized pieces
2. In a non-stick pan, pour the olive oil enough to cover the entire base of the pan. Heat the oil with a low-medium heat for about 1 minute and add the pancetta. Cook until the fatty part becomes translucent and lightly crispy. Be careful not to burn it.
3. Once your water is boiling, add the spaghetti and cook them for the duration indicated on the box. In the meantime, pour the eggs in a bowl, add the majority of the Parmesan cheese. Add black pepper, and mix with a whip, then set aside.
4. When bacon seems ready, add whipping cream and mix with a wooden spoon. Lower the heat to low and bring to a low boil. Add the egg mixture into the pan and mix until well blended and creamy.
5. If you like black pepper, you may add more of it, too. Enjoy! Buon appetito!

## CASES OF INTEREST: JUNE 2024

### THREE-WHEELED MOTORCYCLE CRASH:

We represent an elderly client who was rear ended while driving a three-wheeled motorcycle. The client sustained severe back injuries from the crash and other residual complications from being in the hospital. Our aggressive representation resulted in the at fault driver's insurance company paying out the policy limits. We are pursuing additional recovery of underinsured motorist benefits.

### DISMISSED CASE AFTER OUR CLIENT WAS FALSELY ACCUSED BY A NEIGHBOR:

A fire in the Rosewood area that started near the end of Southwest 124 Terrace, approximately one-half mile north of SR-24 and about one mile west of Shiloh Road, burned about 150 acres according to a Levy County Sheriff's Office. Fire crews from Cedar Key, Chiefland, Fanning Springs, Inglis and Bronson responded. The cause of the fire had not yet been determined. 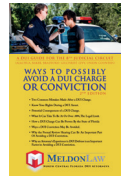
